At 3:10 AM, 9/13/08, the rain started. At 5:36 AM, the strong winds hit. Our lights went out around 6:15 AM with strong winds from the North east. At 8:00 AM, the strong winds changed from North to West and at 10:00 AM the weakened winds changed from West to South.

At 2:00 PM, on Monday, September 15, 2008, Street Brothers started their task of removing all of the trees and debris from our streets

Wind and rain continued all day. The clouds started to break up and we saw the moon at 9:17 PM. Then came Sunday morning, our streets and beautiful trees were devastated.



Hundreds of trees and limbs were blown down throughout Waterwood (see photos on pages 6 and 7). Waterwood was "blessed" because no one was injured and very few homes were badly damaged. No subdivision was spared. The Doral area had the worst damage.

Street Brothers quickly came to our aid had most of Doral free from debris in one day. They will continue through Waterwood until all of our community is cleared.

On Monday, 9/15/08, the WIA Board voted to hire Street Brothers of Coldspring to come into our community and pick up the debris and haul it off.

The electric people told us that it could take till the end of the month to get power back to our community. Would you believe, we got power back around 11:00 AM on Friday 9/19, **YEA!**

Congratulations go out to the WW VFD. They now have 17 members. These people were clearing our streets just as IKE was passing. They cut and moved the downed trees off of the major streets. THANK YOU!

Another "THANK YOU" goes out to four people who served our community as directors on the WIA Board. Their terms expired and they attended their last full Board Meeting on 9/15/08. Many accolades for serving Waterwood go out to Baldomar Garcia, Ken Hicks, Pat Nabers and Pat Willborn.

WNN hasn't heard much about the Club situation during the past month. We don't have any good or bad news to report. Lets keep our fingers crossed.

Computer Corner

Most of us have no problem with getting rid of the old clunker and get something faster, more efficient, cleaner, newer, and more reliable.

However, for some reason we look at the computer different. A four or five year old computer is comparable to a twenty to thirty year old car.

Let's look first what might break on your computer. Your computer is like your car. It is made up of components that can be replaced.

1. Power supply – Symptom, it won't start. Dead. No noise. No power. These are easy to replace, cost between \$25 and \$75 dollars.

4. Mother Board. It won't boot. It crashes. It smells like it is on fire. Cost between \$100, and \$500 to replace it. I have never replaced a mother board, and never will.
5. Miscellaneous parts and pieces. CD/DVD drives, Floppy drives, video boards, modem boards, etc. These may or may not be easy to replace. Most drives are, however boards are another thing. If they are modular, they are easy to remove and plug in.

The Board approved the 2007 Audit as presented. This Audit will be presented to the Waterwood property owners at the annual meeting in October.

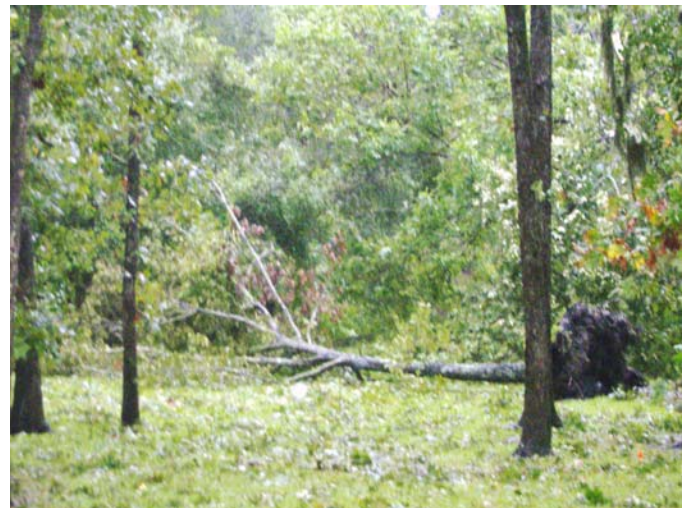
Our Security team received a new Dodge Charger. It is being used on the night shift. Security traveled 6,157 miles during the past month patrolling our community.

After a brief executive session relative to personnel, the Board Meeting was adjourned at 11:35 AM.

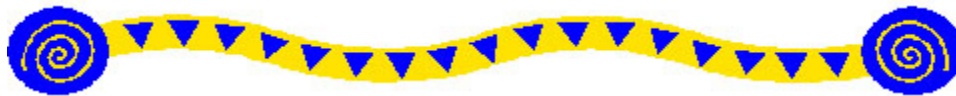
